# Select Board Corner

Dear Neighbors;

Snows are melting rapidly and before you know it, we will be voting on our town warrant articles in June.

Each article looks to the future from funding small but important services to long term investments for our town. Non-financial questions about ordinances and other matters are equally important regarding Readfield's future.

There is one question, Article 40, which is non-binding that I wish to address:

"The following is a non-binding question to establish interest and guidance for future town considerations: Should the Select Board in 2021 and 2022 pursue the establishment of a fiber to the home high speed internet network available to all residents?"

I believe we should but learning about your current interest to guide planning on this essential service is very important to town leadership.

One may note that I am calling high speed internet an essential service. To me, just like the roads that connect us together, carry our children to school, allow us to transport essential goods, participate in governance, get to town services, and take us to work, shopping, and play – high speed internet is the same kind of vital infrastructure we need for the future.

The pandemic exposed our weaknesses in this area and opened our minds to possibilities and needs. To varying degrees we relied on internet connectivity to bring us together, carry school to our children, order delivery of essential goods, participate in governance, access town services, and enable us to work, shop, and even play.

There is much more that a highly reliable fiber network can do from greatly securing the ability for individuals to work from home and pursue entrepreneurial endeavors to the delivery of high quality tele-health services. And just like when rural electrification came, there were applications not even thought of that became new realities improving lives. Who expected hanging that initial light bulb would be followed by reducing the chore of washing clothes, cooking meals, and eventually putting computing power in our hands?

A direction that greatly increases service capacity, is attractively cost effective, and available to every single resident is the one I am encouraging. I hope you will vote yes on this non-binding question to advise the town to make this service a top infrastructure priority with the same future vision the initial Readfield roadbuilders possessed.

## From the Town Manager

#### Readfield Comprehensive Plan Update Underway!

Last fall we announced that the Select Board had formed a Comprehensive (Comp) Plan Committee to update the 2009 Plan. The Comp Plan update process is a chance for our community to get together and really talk about our town. What do we like about Readfield? What might we like to change? Where do we want to be in the future? We will talk about all of these things and revise our community goals as part of the updated plan.

Over the winter and into this spring the Comp Plan Committee met to become familiar with one another, review background documents, and develop a work plan. They are taking a very deliberate approach to the planning process and have placed a premium on public engagement and participation. They have committed to ensuring public comment happens at every meeting and that meetings are recorded for those not able to attend in person. In support of these efforts Town Staff have developed a dedicated page on the Town website to house meeting agendas, minutes, videos, and the many documents that will be used to revise the current Comp Plan. We want to give the public every opportunity to be aware and involved!

### **News From The Broadband Committee**

The committee met in March and published minutes from our February meeting that are on the town website. We will soon have a page on the website for this initiative to make finding information easier. Our March meeting consisted primarily of a discussion with our consultant, Brian Lippold of Casco Bay Associates, concerning details of the technical aspects of the FTTH (Fiber To The Home) proposal and financial proforma for our town. A much greater understanding of the documents was gained by all in attendance.

We are moving forward in two areas: investigating how our current service providers, Spectrum/Charter and Consolidated, could improve current service and expand service to all unserved areas, and continuing our work with the WKLCBA in bringing FTTH to all properties that receive electricity currently. These two items will be the focus of both our meetings in April.

### **News And More News**

Universal Broadband service has become a focus in every level of government in recent weeks. Maine is providing small amounts of money in the proposed budget and trying to find ways to provide more funding. Counties are forming leadership commissions to bring towns together in searching for ways to provide more universal service. MMA (Maine Municipal Association) is making broadband their primary focus for the coming year to assist towns in all areas surround broadband. Local collaborative groups of towns are forming together to create proposals that could see cost savings through regional efforts. Readfield is on top of this process, and we hope to able to take advantage of all opportunities to expand-service and decrease costs as they become available through government programs.

### **WKLCBA** Information

Readfield is a member of the Western Kennebec Lakes Community Broadband Association along with five other towns: Fayette, Leeds, Mt. Vernon, Vienna, and Wayne. We are working together to find solutions for the affordable delivery of high speed, reliable broadband internet access to all locations in our towns that have electric service. ### Interesting Developments In The Broadband Initiatives

The Federal Government has allocated funds from the most recent Economic Stimulus Package to every state. The funds are being distributed thought a formula to the largest cities, to all counties, and to all towns. Readfield is expected to receive \$260,000 that must be used for some type of infrastructure project that will serve the entire community. Broadband has been specifically mentioned as a use of this money in communities that lack service to all residents. The money will arrive half in 2021 and half in 2022. The Library continues to encourage minimal in-person interactions by asking patrons to make use of Curbside Pickup services when possible. Please call 685-4089 or email librarian@readfieldmaine.org to place an order for Curbside Pickup during regular library hours.

In-library browsing and services (photocopier, WiFi printer, patron laptop) ARE AVAILABLE as well during regular library hours. Please use the "Golden Ticket" system (in the basket at the side door) and note that we will be limiting in-building services to 1 patron/family at a time. You no longer need to call to make an appointment to come inside, but please note you may have to wait a few minutes in the parking lot if there is already a patron inside. Face cover-

### Week 1 - Red Flag Warning - Gift Card Payments

A key part of being able to spot a scam is knowing the red flags – those signs that suggest that just maybe what you're confronting isn't legitimate. One of the biggest red flags these days is anyone who tries to convince you that you owe some debt or other obligation, and the quickest way to address the issue is to purchase gift cards and share the information off the back. Why gift cards? First, they are readily available. You see them at your grocery store, department store, and hardware store. Second, it's a way that criminals can get your money instantly and the money is easy to move around. As soon as a target sends the numbers to the gift card they've purchased, the criminal is able to convert it to currency in an instant. Not surprisingly, the Federal Trade Commission reports that gift cards have been the most common form of payment in scams since 2018.

Anytime you are directed to pay a debt or other obligation with a gift card, it is a scam.

#### Week 2 - Avoiding IRS Collection Scams

Tax time is here again and so are the IRS impostors! Scammers posing as IRS agents or Treasury Department officials are out there once again, calling to convince taxpayers that they owe back taxes and face immediate arrest. Know this: the IRS will initially contact you through the mail if you owe back taxes. If you receive an unexpected phone call, an email or a text indicating it's from the IRS, do not engage. Report the scam attempt to the IRS at 800-366-4484 or www.tigta.gov. If you receive an email, forward it to the IRS at phishing@irs.gov, and then delete it.

#### Week 3 - Social Security Scams Rule

2020 was the year of new twists on scams. There were COVID testing scams, miracle cure scams, stimulus scams and vaccine scams, but one scam stood out above them all. The Social Security impostor scam.

Social Security impostor scams continue to be the most prevalent in the United States. In 2020, the Social Security Office of Inspector General received well over 700,000 reports of Social Security impostor scams, and 70% of the calls to the AARP Fraud Watch Network Helpline were related to Social Security impostors.

Remember, the real Social Security Administration will not call you unless you are already in discussions with the agency on a particular issue. They certainly won't threaten to cut off your benefits or seek to "help" with an identity theft problem. Anyone who does is NOT from the Social Security Administration.

#### Week 4 - Do Me a Favor Clergy Scams

The ongoing remote world we're living in has many of us getting used to doing more of our activities virtually. When we can't be face to face, it makes for rich targets for adept scammers.

One trending scam is when a criminal impersonates clergy. The crook spoofs the e-mail address of a given faith leader and sends a message to a congregant requesting a favor. They will claim they are busy or out of town and just need you to purchase a dozen gift cards that will be used to help congregants in need. All you need to do is buy them (say, \$100 each) and email a picture of the front and back of the cards. And of course, you will be reimbursed.

If you're ever asked to do a favor like this, take a pause and think, "Would this person really ask me to do this?" Contact the person yourself and get validation they are who they say they are. And if the request was for gift cards, you'll learn it was a scam attempt.

# READFIELD TRAILS building community a step at a time

### FROM THE TRAILS

Early Spring? Limited Mud Season? April Blizzard? Black Fly / Mosquito free Summer of 21? Feel free to pick from the choices above but with any one or all of the above, the trails in Readfield can help you cope with whatever nature decides to do in the coming months.

With spring here, our usual work day with Kents Hill School may be back on the calendar after being canceled last year for the obvious reason. The Readfield Conservation Commission and Trails Committee have been in contact with a teacher at Kents Hill School about possibly arranging some volunteer time, socially distanced etc., for work at Torsey PondNature Preserve as well as at the Fairgrounds Trails. This possibility has just sprouted this last week of March but hopefully the details can be worked out for this to happen.

The Readfield Select Board approved an agreement with the Greater Augusta Utility District (GAUD) last month to build a trail at Carlton Pond Preserve. Rob Peale from Trails Committee and Brian Tarbuck from GAUD have worked together for several months to put this concept in place. Construction by all volunteer labor is set to begin later in the spring.

Another location that will see some maintenance work in drier weather is the Esker Trail that has a starting point at the RSU #38 bus garage and skirts the former transfer station location and leads to an esker about a mile from the trail head. A section of the original trail was re-routed and now needs some buildup with wood chips. During the winter that trail experienced some heavy blow down of trees in exceptionally strong wind conditions October thru December. Volunteers cleaned up the fallen debris.

For several years our Trails Committee meetings have been on the fourth Tuesday of the month at 6:00 pm. We now meet the fourth Wednesday of the month to help accommodate another town committee. During the past year with only two exceptions, we have been part of the ZOOM crowd in the months meetings were held.

The Trails Committee is presently updating our Strategic Plan and will be working with members of the Comprehensive Plan Review Committee and other groups in town to develop a Comprehensive Plan for 2021 and beyond.

The Trails Committee has plans to sponsor an event for Heritage Days in August and we will keep you updated on that front. For now plan to spend more time outdoors and refresh in some warm weather out and about on our town trails.

# Solid Waste & Recycling

#### Which Bin Does It Go In?

The COVID-19 pandemic has highlighted the critical role of the materials that residents all over North America place in their recycling bins. With more people working and living at home and 40-50% of everyday materials depending on recyclables as feedstock, residential recycling programs have been revealed as essential over the past year. But contamination - items placed incorrectly in the recycling bin - can degrade the quality and quantity of these important materials.

Erik Street, Yarmouth's Public Works Director and ecomaine's Vice Chairman, added "it's important for Mainers to know what is and what isn't recyclable – it has a direct cost to municipal budgets that are already stretched as it is. Keeping recycling clean helps to keep all our costs lower."





#### SOME OF THE FORMULATING SUMMER PLANS

As we start to see the light at the end of the tunnel on this year long pandemic we are thinking about the coming summer with optimism. June 11th is the 100th anniversary of a devastating fire that nearly wiped out all the buildings at Readfield Corner. A history walk is being planned in remembrance of that tragic event. Stay tuned for details on that and for another history walk at Stevens Center in Hallowell, named in honor of Nellie Stevens who was born and raised in Readfield. There will be other events as well. Watch for announcements and read on for more about Nellie.

#### NELLIE FRENCH STEVENS (1891-1988)

Nellie Stevens was born on a farm on Winthrop Road that her grandfather David Stevens of Wayne had purchased in 1860. Her widowed mother, Charlotte (French), sold the homestead in 1923 but it always held a special place in Nellie's heart. During her late years Nellie and a friend often enjoyed Sunday dinner at the Weathervane, where they would sit by a window overlooking the lake and Nellie would reminisce about her childhood on her family's lakeside farm.

Nellie never married but unlike most spinsters of her time, she did not live with family members but lived independently and enjoyed two careers in her lifetime. As a young woman she attended the "Maine Wesleyan Seminary and Female College" and the "Morse Conservatory of Music" (Kents Hill School). She became an accomplished musician and instructor, providing private lessons in Readfield until 1920 when she became Assistant Director of Music at "Coburn Classical Institute" in Waterville. In 1930 Nellie took a sabbatical from teaching to visit her maternal aunt, Fannie (French) Morse, in Hudson, NY where her aunt was serving as superintendent of the "New York Training Center for Girls". Fannie was a pioneer in the field, having worked at similar institutions in Lancaster, MA and the "Sauk Center" in Sterns, MN since 1884. Nellie was so taken with the school mission that she resigned her position at Coburn and remained in New York to be mentored by her aunt. From there she worked in Framingham, MA at a reformatory and prison until 1933 when she was invited to take the position of superintendent at the "State School for Girls" in Hallowell, ME. She accepted and adeptly filled the role. Her grand piano was moved into her apartment on campus, so she could continue to provide music lessons, but this time to "her girls", as she called them. Nellie remained superintendent until 1959 and on the day of her retirement was surprised by the announcement that the school would be renamed "Stevens Training School" in her honor.

After decades of neglect and decline the buildings at Stevens Training School are undergoing significant changes. Now known as "Stevens Center", the most recent change is the addition of a restaurant named "Nellie's Kitchen" in Nellie Stevens honor. A memory board is being added there, about Nellie. Should anyone reading this article have something they would like to submit for consideration, contact crossings4u@gmail.com. A Readfield History Walk of the grounds followed by lunch at Nellie's Kitchen will be held later this spring.
