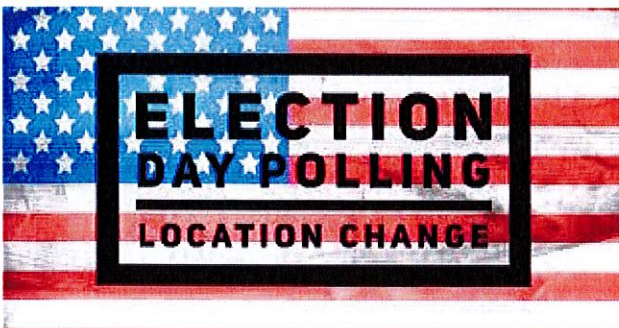

Town of Readfield Covid -19 Updates

This update summarizes our action plan as we enter the 2021 summer season, effective immediately unless otherwise noted.

Town Office

- ⇒ The Town Office will continue to be open to the public without an appointment during regular business hours. Residents are still being requested to utilize our many [online services](#) as a convenient alternative to coming by the office.
- ⇒ Effective May 24th all vaccinated residents and staff will no longer be required to wear masks while in a public space at the Town Office. Unvaccinated residents and staff must continue to wear a face covering.
- ⇒ Town Office “Senior Hours” for residents over the age of 65 or with special medical considerations will be ending effective May 24th.
- ⇒ Effective May 24th there will no longer be a limit on the number of municipal employees or residents allowed in the Town Office.

Transfer Station

- ⇒ Customers are no longer required to wear masks at the Transfer Station. Effective May 24th, vaccinated staff are no longer required to wear masks at the facility. Unvaccinated staff must continue to wear masks.
- ⇒ “Senior Hours” for residents over the age of 65 or with special medical considerations will continue on Thursdays from 10-2.
- ⇒ Staff will not be handling bagged waste or assisting with unloading.
- ⇒ Used tissues, wipes, paper towels, latex or rubber gloves, or other protective / used cleaning supplies are not allowed in the recycling. Please put them in the trash.

Public Meetings and Communication

- ⇒ We will begin returning to in-person board and committee meetings as a primary mode, but will make significant efforts to continue to offer virtual participation options, recognizing that these hybrid meeting can be technologically challenging.
- ⇒ Those interested in attending, listening, or watching public meetings and proceedings remotely should look for web conference and teleconference links and instructions on meeting notices and agendas.
- ⇒ Effective May 24th we will return to full capacity on the 2nd floor of Giles Hall (approximately 100 people).
- ⇒ Public rentals of the 2nd floor of Gile Hall will be once again be allowed effective May 24th, with the addition of a non-refundable \$25 cleaning fee for all users.
- ⇒ The Readfield Beach is once again available for rentals for special events.
- ⇒ Phone and email are still the best way to reach municipal staff and appointed and elected officials. Call the Town Office at 685-4939 or visit the website for this information.

Readfield Conservation Commission

The Readfield Conservation Commission (RCC) manages four town properties, totaling 253 acres, for their conservation and recreational values. Torsey Pond Nature Preserve, Readfield Town Farm and Forest, Fogg Farm Conservation Area, and the Readfield Fairgrounds provides residents with opportunities to immerse themselves in natural surroundings and to safely recreate. People engage with the properties in many ways, including dog walking, birdwatching, hunting, and active recreation, such as baseball and jogging. Torsey Pond Nature Preserve sees regular use by people who return again and again to enjoy the network of trails on the property and the panoramic view of the pond, marshes, and floating islands. The Readfield Fairgrounds provide a safe place to walk and enjoy the broad vistas of fields and Maranacook Lake. The recreational field on the property serves a vital function for area youth league baseball teams. In season, many people come to watch their kids play, making memories with every game.

All four properties demand regular attention, whether it's removing fallen tree branches and limbs from the trails after a storm, repairing footbridges and culverts, maintaining walking surfaces, or making sure adequate signage and trail blazes are in place on the properties so visitors don't lose their way. Members of the RCC (along with the town's Trail Committee) attend to these needs and more. The thick shrubby growth obscuring the foundation of the old Town Farm at the Town Forest caught our eye every time we visited. Not wanting to lose an important part of town history to neglect, RCC members convened in late October 2019 for one of their many workdays to trim back the overgrowth in and around the foundation. The commission's hard work brought to view once again this important local historic site.

More recently, the RCC replaced the trail signs at Torsey Pond Nature Preserve. New signage was long overdue as the old signs were in serious disrepair and no longer functional. RCC member Jerry Bley reached out to the Maine State Prison in Warren to engage their services in making new signs. The commission hired prison workers to manufacture 24 wooden signs to replace all the existing ones at trail intersections, the preserve entrance, and other locations of interest. Workers used 1½-inch thick cedar for the signs and engraved each with the trail name, directional information, and/or points of interest. The craftsmanship shown by the prison workers in designing and making the signs was laudable. And the cost for all their labor in this effort was only \$360!

All the trails at Torsey Pond Nature Preserve are named using colors (e.g., Blue Trail, Orange Trail) for ease of navigation. The lettering for the new signs is likewise color-coded to match the trail names. Before placing the new signs, Jerry and his daughter, Amy, applied stain to protect the wood from the weather. Jerry and commission member Greg Leimbach took down the old signs, which crumbled into pieces when removed, and put all 24 signs up over a couple of work sessions in early May. Other work this spring at the nature preserve repaired washouts along the entrance trail from heavy rains over the past year. Several RCC members worked to mitigate the damage by building water bars and installing a box culvert to direct water off the trail and down the slope. As is typically the case, all materials used for the repairs, including bluestone and lumber, were hauled by hand to the work site.

The RCC's many efforts to maintain and improve the town's conservation lands are funded by an income stream derived from tree harvesting at the Town Forest—no property taxes are needed. The Readfield Conservation Lands Account is replenished every five years as blocks of forest land are selectively harvested in accordance with the town's forest management plan. The funds are used only for management of the town's conservation lands.

RCC members invite all town residents and other visitors to come and enjoy the town's conservation properties. Each property offers a different outdoor experience, whether the opportunity to birdwatch from the viewing blind at Torsey Pond, view historic sites and forest management at the Town Forest, or breathe easy in the spacious fields in and around the Readfield Fairgrounds. The commission members have worked hard to keep the properties accessible to everyone. Please come!

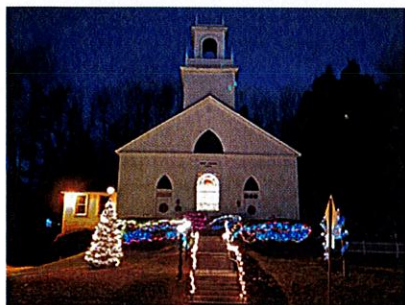

RULES OF THE READFIELD TOWN BEACH

1. All users of the property are required to have a season permit or purchase a guest pass.
2. All users of beach, water and property assume all risk. There is **NO LIFEGUARD** available at any time.
3. Beach hours: 9:00 am – 8:00 pm.
4. All attendants have the right to stop any behavior which they feel is dangerous.
5. All posted public health rules must be followed.
6. All children 14 and under must be supervised by an adult remaining on the property at all times.
7. When arriving at Beach please:
 - a. Drive slowly and use caution in parking area
 - b. Show permit to attendant on duty (or purchase day pass from attendant)
 - c. Keep permit visible on dashboard at all times
8. Possession or consumption of alcoholic beverages or drugs is prohibited.
9. No glass of any kind is allowed on the property.
10. No animals of any kind are allowed on the property.
11. All boats (including windsurfers, canoes, and kayaks) are to be kept out of the swim area, and may come ashore on the west side of the beach, outside the buoys.
12. No fishing allowed within the beach buoy area.
13. No swimming beyond the buoys and no rough play anywhere.
14. The use of floats and rafts in the swim area will be limited by the discretion of the attendant on duty.
15. Swimming diapers are required for all children wearing diapers. Soiled swimsuits or diapers may not be rinsed out in the lake. Failure to provide a swim diaper for your child while in the water is cause for immediate revoking of your permit.
16. There are no trash cans available anywhere on the Beach property; therefore we have a “carry-in, carry-out” policy for all trash.
17. There is absolutely no tobacco use or vaping allowed anywhere on the property.
18. All holes dug in the sand must be filled in when play is finished.
19. Permit holders wishing to have any group function should call the Readfield Town Office at 207-685-4939 in advance to arrange fees and schedule times.
20. No inappropriate language of any kind will be allowed.
21. All music must be kept to a level as to not to disturbed others using the beach.
22. All grill fires need to be doused with water before leaving.

**TERMS OF AGREEMENT
FOR RENTAL OF CANOE/KAYAK STORAGE RACK - READFIELD BEACH**

1. Rack space rentals are available to current year Readfield Beach Pass holders over 18 years of age.
2. Cost of one rental rack space is \$40 from May 1 – November 1. Rental fee must be paid prior to the start of storage.
3. Maximum length/width for the canoe/kayak racks is 18'0" / 2'4". Paddleboards, sculls, etc. may also be stored.
4. Rack rental is not allowed for any watercraft used to access a moored vessel.
5. Rack rental is on a first come, first served basis. Upon receipt of completed application and payment, racks will be assigned by number. Rack rental and assignment is at the discretion of the Town Manager or designee.
6. Before storage, Owner must attach their assigned rack number to the canoe/kayak by a secure means.
7. Owner agrees to remove canoe/kayak by November 1. Failure to remove canoe/kayak from rack by date stated will result in the inability to rent during subsequent seasons.
8. Owner must ensure the canoe/kayak is reasonably secured in its assigned rack and will not pose any danger to any passersby. Owner must provide locking mechanism.
9. Owner must ensure the canoe/kayak rack space is clean and tidy at all times. Nothing other than one canoe/kayak can be left on, in, around or by the rack at any time (e.g., paddles, floatation devices, etc).
10. Canoe/kayak may not be left outside the designated storage area.
11. The storage rack unit may only be used for the one canoe/kayak listed above. Eight rack spaces are reserved for paired use. Paired spaces are 1-2, 3-4, 11-12, 13-14. There is a one space (or paired space) limit per household.
12. Owner acknowledges that canoe/kayak storage rack rental is at their own risk. The Town of Readfield accepts no responsibility for loss of or damages to the canoe/kayak. Failure to comply with above terms will result in termination of this agreement with no refund of rental fees.

I agree to abide by the rules and regulations stated above and I hold myself solely responsible for any mishap/injury or damage to the canoe/kayak listed above.

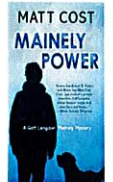

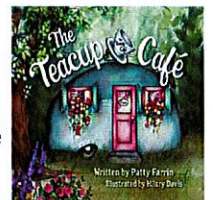
BOOK BUDDIES—New Summer Program for Youth!

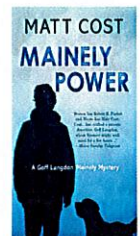
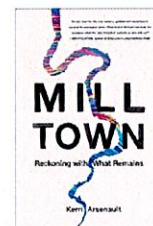

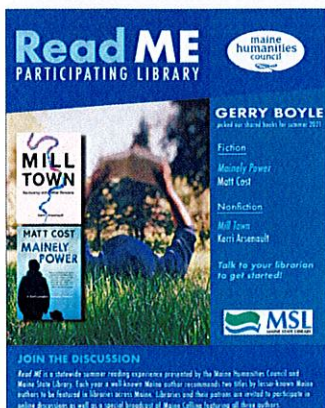

FROM THE TRAILS



Since our last Readfield Trails article appeared in May's *Messenger*, several events have taken place with regards to the town trails. There has been a noticeable increase in activity at the fairgrounds complex. With the warmer weather enticing people to get outside, anyone traveling Church Road can't help but notice the parking lot at the fairgrounds has many more vehicles parked there, especially in the early evening as baseball is back at the field. The new circuit trail on the outside of the large rock border that was completed last summer has helped to keep kids, adults, pets etc. safe as they navigate down to the field.

Later this summer, a major maintenance initiative to re-surface sections of the trails at the fairgrounds is in the works. An Age Friendly Committee grant and volunteer labor will get the project completed. In August a ceremony postponed last summer due to, well you know what, will be held in conjunction with the Maine Bicentennial to honor part of Readfield's past connected to the yearly fairs held at the fairgrounds. The plan is to have some of the remaining pulling stones moved by oxen to a "display" area in the woods just off the trail. There will be informative signage to complete the display. This event is a combined effort by the Readfield Historical Society (RHS), Readfield Conservation Commission (RCC), and Readfield Trails Committee (RCC). The event is tentatively scheduled for Heritage Days on August 14. Make plans to attend this unique part of Heritage Days.

Recent trail maintenance at the Torsey Pond Nature Preserve (TPNP) done by the RCC improved drainage. A box culvert that was installed at the bridge and water bars constructed on the Orange Trail will divert water away from the trails and should alleviate flooding and washouts that occur during heavy rains.

Four Trails Committee members recently spent 2 hours improving a re-routed section of the Esker Trail. Brush cutting and wood chip covering should make hiking more enjoyable. A special thank you goes out to Anna Carl for getting the wood chips delivered to the work site.

With Maine's, and specifically, Readfield's success on helping slow the spread of Covid 19, the RTC recently had its first in person meeting at Giles Hall after several months of either postponed meetings or ZOOM events. Naturally, the CDC and Readfield's mask and socially distancing guidelines were followed. In attendance at the April 28th meeting were the committee's two newest members. Readfield residents Jackie Drouin and Steve Hayes volunteered to join our group and promptly got involved. Welcome Steve and Jackie! A special thank you goes out to all our Trails Committee members for their patience and involvement during the past 14 months. You are a stellar committee of dedicated volunteers and I appreciate your efforts!

RTC meetings are held the fourth Wednesday of the month at 6:30 at the Town Office. We welcome resident participation at any level and are always looking for volunteers on our trail work days. Contact Greg Durgin if interested at durgie@roadrunner.com or 685-4481.

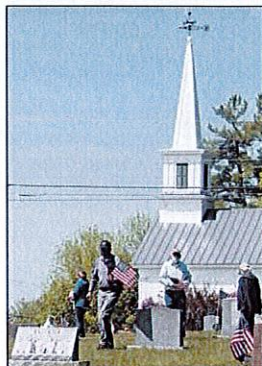
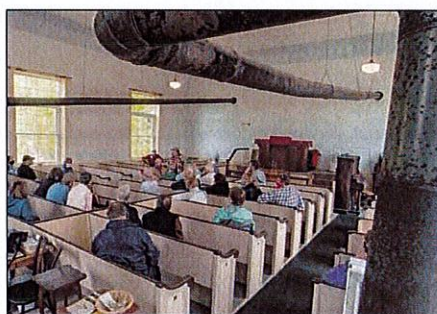

COVID-19

Caseload in Maine continues to decline

CDC reports 117 new infections, 1 additional death

The Maine Center for Disease Control & Prevention reported 117 new COVID-19 cases and one additional death Sunday, the lowest number of daily infections announced since Feb. 17.

Maine is set to lift its indoor mask mandate starting Monday, with a few exceptions. Schools and child care facilities will still require masks and the U.S. Centers for Disease Control & Prevention has mandated face coverings on public transportation.

Gov. Janet Mills made the change last week after the U.S. CDC announced that masks were no longer required indoors for vaccinated people, but Mills' order extends to unvaccinated people, too, because of the difficulty of determining people's immunization status on the fly in public.
