Code Enforcement

FINISH WHAT YOU STARTED

As the end of 2021 approaches, if you started any building or plumbing projects, many things should be reviewed to start 2022 right. The first thing real estate or financial persons ask

when they call the Code Officer office is "Are there any open permits or does the property have a Certificate of Occupancy?"

If you opened a building permit this past year know it is valid for one year from issuance. Readfield ordinance states: "Following the issuance of a permit, if no substantial construction start is made, or use of the property is initiated for which such permit has been issued, within one year of the date of the permit, the permit lapses and becomes void. However, the permit may be renewed for one additional year if no material change in the proposed use or applicable Ordinance standards has occurred."

FINISH the task! All permits demand inspections to be valid. Sub-surface (septic) and internal plumbing permits involve two inspections. The first needs to occur when plumbing is roughed in (before covered) and the septic permit after the footprint of the field is roughed out and scarified. The second inspection occurs when the project is complete, the permit will be signed and dated after each inspection and will be held on file as proof of proper installation and permitting. The building permit is closed out when the project is inspected for its Certificate of Occupancy, CO. Once the CO inspection is successful you will be given a printed CO, keep it on file for future transactions.

When you are looking to get land related legal matters or financial transactions in progress things are complicated if you have not finished inspections and CO granting, do it now so you don't have to stress later. I stand to answer your questions or requests quickly, just call me at Town Hall, Chip 207-685-2390. Merry Christmas, Happy Holidays and a Happy New Year to all.

From the desk of your Local Health Officer

I hope all had a Happy Thanksgiving and are preparing for a great Christmas and holiday season coming up. Please get your COVID vaccinations and boosters so you can celebrate with family and friends without worry of giving the Virus for Christmas. Spread the cheer not the virus!!



On a different but particularly important note as we enter the beginning of winter – Brown Tail Moth, BTM, should be addressed now through mid-April. Last year the

Readfield area had a documented increase of Brown Tail Moth infestation and, if you were like me, you may have experienced the toxic hair consequences from BTM. The State Department of Agriculture and Conservation has warned that the infestation could be worse next spring/summer depending on the winter, the natural evolution of the BTM outbreak and other factors. There is a wealth of information on the Maine Web State site: https://www.maine.gov/dacf/mfs/forest_health/invasive_threats/ browntail moth faqs.htm#management or just do a google search on: MFS BTM.

There are suggestions on Brown Tail Moth elimination and answers like: Are pesticides safe for your family, pets, and other important insects such as pollinators and natural enemies of BTM? You will find suggestions on arborists that can be tasked to cut out nests, actions you can take on your own, and requests for gathering local BTM nest's locations to aid the State track infestations. Land areas here with predominate oak and fruit tree locations can result in heavy infestation which can be problematic for heavy BTM toxic hair exposure that can be akin to a bad poison ivy exposure, but also respiratory and other serious outcomes.

Those who remember the Gypsy moths' devastation in years past, those infestations ended by a natural fungus emergence and evolution that wiped out that pest. Hopefully, this will eventually be the end game for the BTM pest but until then we can have influence by dealing with BTM nests over the winter months. Learn how to safely eliminate or lessen this toxic pest. Find out how to look for, cut and burn nests, utilize proper and safe pesticides, or hire a professional to assist you and your family. Do not wait until next spring/summer when we all want to be outside doing the summer thing without the itch.

Thank you for your help. Have a wonderful Christmas or holiday celebration and lets all look forward to a Healthy Happy 2022.



Helping People. Changing Lives.

You can get help paying for your home energy bills and emergency home heating fuel delivery from the Home Energy Assistance

Program (HEAP).

Fuel assistance

HEAP is a program that can help pay part of your annual home heating costs. Your benefit amount is based on several factors, including your household size, income, and home energy costs.

Emergency assistance

More help may be available if you have less than a three (3) day supply of heating fuel. We may also be able to help if you cannot pay your bill and your services may be disconnected.

Am I eligible?

Anyone who may need help paying for their home heating costs should apply for the program. Please apply even if your application has been denied before. Apply even if your income may be over the income limits because some expenses may be deducted. Homeowners and renters may apply. You can also apply even if heat is included in your rent. Find more information at mainehousing.org/heap.



How do I apply?

You apply through your local Community Action Agency (CAA). You can apply in person or over the phone. Ask your CAA what documentation you need to have when you apply. Find out more information at mainehousing.org/heap.

What to expect

Appointments fill up fast and it may take a while to get an appointment. It usually takes several weeks to process a HEAP application. If your HEAP application is denied, you can reapply if your circumstances change.

Other help available

If you are approved for HEAP, you may be able to get help with your electric bills through your electricity utility company's Low Income Assistance Plan (LIAP).

Help with home energy costs may also be available through your local General Assistance Program.

Solid Waste & Recycling



Apparel Impact is a textile recovery company that began as a small family operation in 2014 in New England. Their aim was to collect clothing, shoes, and textiles of all kinds to keep them out of landfills, provide resources to assist with local poverty and to create jobs. They wanted to change the way we all think about clothes. They have now grown into a nationwide company with the same goals. Readfield is glad to partner with this worthy company as their goals align with ours to Reduce, Reuse and Recycle.

Approximately 10% of trash placed in the MSW (Main Stream Waste) bin is textiles. By utilizing the Apparel Impact bin, we can reduce the amount of waste going into the local landfill in Norridgewock, allow for useable items to be given to those in need, and recover fibers to be used for new manufactured items.

All of this also saves cost to the town in tipping and transportation fees.

The collection bin is located straight ahead as you pull past the attendant booth, next to where you can drop off electronics and light bulbs, all near the metal bin. Items placed in the bin do not have to be laundered, wearable or useable. Please see the list here for what can be placed in the bin. For more information visit www.appaelimpact.com on the Internet.

As daylight hours shorten, please take extra care while at the Transfer Station. Be mindful of folks walking to the bins as well as being careful where you walking, especially when leaving compost, brush or appliances.

General Operation Practices

All vehicles must stop at the Attendant Booth to speak with an employee about what materials you are bringing in, to receive directions on where to dispose of these materials, and to pay any required fee.

NEWS & NOTES FROM THE TRAILS

Hello trail enthusiasts.

The trails committee has been busy this fall with significant work accomplished on multiple trails. There are many community volunteers who contributed to this work. On October 28 two Readfield tractor owners supported trails committee members and a contingent of two teachers and eight students from Kents Hill School in spreading bluestone to repair worn areas of the Fairgrounds Trail system. In addition to this work three trails committee members spent a Sunday afternoon removing large stones that have been slowly poking up thru the trail in some cases pushing up the underlying geofabric.

I can also report progress on development of a trail along Carlton Pond. Although this area is still closed to the public due to its designation as a back-up water supply for the Greater Augusta Utility District (GAUD), access will soon be allowed for a walking trail along the pond. An inner gate has been installed which should eventually allow for parking between the inner gate and the outer gate which will then be opened. On November 20 two chain saw operators from the trails committee led four other members, 3 young women from the Readfield Girl Scout Troop (plus two younger brothers), and two adult leaders on the first trail clearing outing on the property. We made great progress and hopefully will be able to open the trail some time next year. For those with snowmobiles winter access is currently allowed through the Carlton Pond property but is limited to the snowmobile trail itself.

In late November additional bluestone was spread on the Fairgrounds Trail by a private contractor at the instigation of the Conservation Commission. This should further help stabilize the trail for the long term.

I would also like to thank Milt Wright for his continuing efforts in performing blazing and loper work on the Esker Trail.

I hope you will all take advantage of the many trail opportunities available in Readfield even when they are covered with snow. Please contact me if you are interested in volunteering for trail work or would consider joining the Readfield Trails Committee.

Our trail maps continue to be available at the town office and on-line (https://www.readfieldmaine.org/sites/readfieldme/files/uploads/readfield_trails_2019_map.pdf).

Please let us know if you encounter damage or other issues when on our town trails.

Dog owners please note: Dogs are required to be on leash or under voice control on all town properties including our trails.



December 2021 State Scam Alerts



Week 1 - Holiday Shopping Tip - Pick the Right Plastic

If you heed only one tip this holiday shopping season, make it this one: pick the right plastic. A recent AARP survey found that nearly 70% of people shopping online this holiday season plan to pay with a debit card. Choosing this form of payment can make you more vulnerable to fraud losses.

Debit cards deduct money directly from the account it's connected to. If your card is compromised and the thief goes on a spending spree, the money drained from your account is YOUR money. When you use a credit card and it's compromised, the thief isn't spending money from your account but rather from the credit your bank has provided.

Both cards are governed by consumer protections – but there's a 'but'. When your credit card is used fraudulently, the issuing credit company will absorb the losses from the shopping spree the thief enjoys. Your costs may be limited to \$50, but most issuers waive that.

When your debit card is compromised, your money is gone until you report it and the bank completes an investigation, which could take several weeks. If you're relying on that account to pay your rent or mortgage, that delay can put you in a real bind. And if you fail to report the fraud within 60 days, you may not have any recourse to recover your losses at all. In other words, it's usually harder to get your money back from the scammer with a debit account.

When shopping online this holiday season do yourself, and your bank account, a favor and leave the debit card in your wallet.

Be a fraud fighter! If you can spot a scam, you can stop a scam.

Week 2 – Gift Card Shopping Tips

Most US consumers will purchase a gift card for someone this holiday season. While these gifts are easy to give and popular to get, they are also open to fraud. A 2021 AARP survey found that one in five people have either given or received a gift card with no funds on it.

Your best bet is to buy gift cards online directly from the issuer. Cards on store racks are easy prey for criminals, who can grab the cards, secretly record the numbers off the back and return the cards to the rack. Carefully inspect cards from the rack to look for signs the PIN has been exposed or manipulated.

And remember, if anyone asks you to pay a debt or obligation with a gift card, it's a scam.

Week 3 – When the Charity is a Con

It's the season of giving, and for those in the spirit, telling the difference between a real charity and a con can be a challenge. Legitimate charities make a big push at year-end for last minute annual donations. Scammers know this and make their own end-of-year push to line their pockets.

If a charity solicits you for a donation, even if your first instinct is to contribute, be careful. Check the charity out before donating. A couple of useful sites for this are charitynavigator.org or give.org. A little research can help make sure you're supporting a legitimate charity – and that the fundraisers aren't keeping most of the money they raise for themselves.

Week 4 – When Elder Financial Abuse is in the Family

Federal data suggest that losses from elder financial abuse perpetrated by a known person are greater than when the fraud is perpetrated by anonymous scammers. With the holiday family visits upon us, it could be a good time to broach the subject. You might bring up the topic of financial exploitation and segue into asking what they are doing to protect themselves and their money. Above all, respect their right to make their own decisions while they are cognitively able, but leave the lines of communication open.

Week 5 – Stress Can Lead to Scams

As we wrap up a second year of pandemic-induced uncertainty and stress, it's important to recognize that in addition to making life harder, these factors actually can make us more susceptible to fraud. A recent AARP study found that victims of fraud experienced more than twice as many stressful events as those who avoided attempted scams.

Stressful events consume valuable cognitive capacity that otherwise might be employed to spot and resist fraud. Knowing this, criminals specifically look for ways to target people who may have lost a job, or recently became a widow, for example. Being aware that you or a loved one's stressful situation may make you or them susceptible to fraud may be the difference between staying safe or being victimized.

Be a fraud fighter! If you can spot a scam, you can stop a scam.

Town Meeting Questions on Broadband



On November 2nd voters in Readfield spoke loud and clear by approving three articles concerning bringing Internet service to all locations in our town. There were 1015 residents who voted out of approximately 2300 registered voters. Of those who filled in a choice the results ranged from 70% to 78% approval.

Article 2: Shall the Select Board of the Town be authorized to negotiate one or more agreements for the provision of high-speed internet service to all Readfield residents through one or more third party service providers, with any final agreement(s) and funding requiring voter approval? 78% in favor

Article 3: Shall the Select Board of the Town be authorized to enter into one or more agreements, at one time or from time to time, and apply for, accept and expend revenues from Federal, State, and private grant sources, either on behalf of the Town of Readfield or the Western Kennebec Lakes Community Broadband Association to offset the cost design, acquisition, construction and equipping of a broadband fiber optic network to be owned by the Town of Readfield and operated by a third party to serve all of the residents of the Town of Readfield? 73% in favor

Article 4: Shall the Select Board of the Town be authorized to (a) enter into, at one time or from time to time, one or more agreements providing for the design, acquisition, construction and equipping of a broadband fiber optic network to be owned by the Town of Readfield and operated by a third party to serve all of the residents of the Town of Readfield, (b) appropriate a sum not to exceed \$5,000,000 for the foregoing, and (c) fund the foregoing appropriation by borrowing, on behalf of the Town, a sum not to exceed \$5,000,000 on such terms as the Select Board determines are necessary and proper pursuant to 30-A M.R.S.A. §5772 and other applicable Maine law, including the issuance, at one time or from time to time, of general obligation bonds (and notes in anticipation thereof) of the Town of Readfield in a sum not to exceed \$5,000,000, including fixing the dates, maturities, denominations, interest rates, places of payment, premiums, calls for redemption with or without premium, forms and other details of said bonds and notes, and to provide for the sale thereof, for the purpose of paying all or a portion of the costs of the foregoing broadband fiber optic network? Select Board recommends: Yes

Budget Committee recommends: Yes

70% in favor

These votes have provided a clear direction to the Select Board and Broadband Committee. Both groups are committed to a prompt follow-through by assessing the available solutions and choosing the best and most equitable one to be presented at a Town Meeting in 2022.

News From the Broadband Committee

The committee met on November 10th and discussed many topics. The results of the Town Meeting vote have provided necessary direction for us to follow. Updates were provided on grant and funding opportunities, vendor contacts, and legislative actions.

The recently passed federal infrastructure bill will provide funding for Broadband but it will go first to unserved areas, then to underserved areas, and lastly to served areas, all over a period of five years. Service is defined at a level that already exists for 92% of Readfield. We know that the stated level of service is not what our residents want or need, but that is what the bill is for. Some of our neighboring towns who are in the WKLCBA (see below) meet these criteria and should be able to secure some grant funding. Basically, Readfield will not qualify for much grant funding as we are considered a town that is served, meaning that Internet services are available to purchase from a provider. There is no metric for the level of service provided nor the quality of that service. We have a very small portion of roads that are unserved, meaning there is no cable run on the road. This is why we asked the voters if we should plan on borrowing to meet the needs of the town

The committee is meeting next in January 2022; a date will be announced in advance. We will be discussing the results of RFP issued by the WKLCBA and what direction to recommend we proceed in. All meetings are public and will be held in person at the Town Office along with remote access. Look for links on the town website and for email alerts if you have signed up for them. Signup for email alerts is available on the town website. We publish monthly updates. www.readfieldmaine.org

WKLCBA Information Readfield is a member of the Western Kennebec Lakes Community Broadband Association along with five other towns: Fayette, Leeds, Mt. Vernon, Vienna, and Wayne. We are working together to find solutions for the affordable delivery of high speed, reliable broadband internet access to all locations in our towns that have electric service. Please see their website to find the studies we have completed, the RFP (Request For Proposals) just issued, and many articles pertinent to this effort.
