The Town of Readfield seeks proposals from qualified contractors to remove snow, control ice, apply salt and sand, and perform other winter road maintenance work on all municipally-owned roads, state-aid roads, and intersections in the Town of Readfield totaling approximately 34.5 miles. The work is scheduled to begin in the fall of 2022 and continue for three winter seasons with the option of extending to a fourth.

There will be a mandatory pre-bid meeting at 10:00am on Thursday, March 10, 2022 at the Readfield Town Office.

Readfield Recreation in partnership with the Readfield Blizzard Busters on Sunday, February 13 hosted our annual Winter Fun Day with Sliding on the school hill. The Blizzard Busters were there to provide the rides back up the hill! There was hot cocoa, a good platter of cookies and whoopie pies enjoyed by all. The snow was a little hard packed but it didn't stop everyone from enjoying the sunny afternoon. Thank you to all who came for the fun!

February 12th was our last morning of Skills and Drills with the younger groups for Rec Basketball. There were 64 total kids who participated in the 7-week long program. We were able to provide each participant with their own ball to bring to session each Saturday but also to have at home and practice their skills. Big thanks to Karen and Travis Magnusson, coaches and Tom Labrie, Rec Basketball Organizer for making the



program a success this winter with the many challenges of COVID. All participants enjoyed ring pops and cookies to celebrate the season on the final morning.



Our 3rd-6th grade groups are still playing through the 12th of March. They have enjoyed weeks of competing in the local league against area schools. It is amazing to have the whole program in full swing again, even among the COVID challenges. We have 93 participants with girls and boys teams, 3rd-6th grade.

Our Baseball and Softball sign ups will go online this week. We are hoping to have all signups completed by March 31st so we are ready to get playing when the snow melts. There are also sign up forms at the Readfield Town office if you prefer to sign up there. We invite Mt Vernon, Fayette and Wayne players to check in with your town and sign up to be included on the Maranacook rosters. Let's play ball!

Lastly Readfield Recreation is working diligently to develop more of a recreational complex at the Fairgrounds property off Church Rd. Currently we are working with a landscape architect and stakeholder representatives from Conservation Commission, Trails

Committee, Cemetery and Historical Society. The vision is to have a complex for all townspeople to use while maintaining the beauty of the property in the process. Recreation's proposal is for a softball field in the back right corner for the outfield to align with the already existing baseball field. We also would like to see an outdoor basketball court located as close to the parking lot as possible for easy access by all. Currently, our next step is to follow up on a walkabout done with stakeholders, town manager, and the landscape architect on January 26th. A Zoom meeting will take place the first week of March for this follow up.

Recreation is also working to apply for a Harold Alfond Grant in hopes to offset the cost of the development at the Fairgrounds property. We are looking at other grants to apply for as well.



We used their field for practicing last year as we did not have enough space for all our teams in Readfield. We are long overdue for the development we are requesting at the Fairgrounds property. It will be amazing to have a centralized facility for all townspeople to enjoy!

NEWS & NOTES FROM THE TRAILS SNOW! ICE! RAIN! SUN! SLEET! FREEZING RAIN! THAW! RE-FREEZE! RAIN PT.2!

Yes, all of the above and more have marked Winter 2021/22. Have those nasties above (except the sun!) turned anyone off from using our trails in town? I don't believe so given the vehicles in the Fairgrounds parking lot and the ski tracks, snowshoe images, and footprints leading every which way at the Fairgrounds and at other trails in town. Readfield residents don't seem to let the weather get the best of their efforts to get out and enjoy their outdoor exercise routines. Keep it up. Spring is less that 40 days away! Those nasties won't dare intrude again, will they?

A resident recently contacted the Trails Committee to let us know of a potential hazard on a section of Fairgrounds trail below the backstop area. A stream was plugged turning the trail into a quagmire not unlike quicksand. Trails Committee members jumped into action and cordoned off the area for safety and within a few short days had the stream unclogged and flowing thereby lowering the level of the backed up snow and slush. We appreciate the trail users who helped re-route the trail deeper into the woods and away from the hazard and demonstrated patience while the work was being completed.

The Readfield Recreation Committee has a proposal before the Select Board for a building project at the Fairgrounds. Their plan is to construct a softball field, a basketball court, and a concession stand on the town property. The Select Board authorized the hiring of a landscape architect to work with information supplied by the Recreation Committee, Readfield Conservation Commission, and Readfield Trails Committee, At this point neither the Trails Committee nor Readfield Conservation Commission has taken a position on the Recreation Committee proposal. That information can be found on the town website. A site visit was held in February with the architect and members of the aforementioned committees as well as members of the Historical Society in attendance. The current draft of the town budget (as of 2/16/22) has the project possibly earmarked at +/- \$500,000.

Readfield Trails welcomes its newest member Megan LaChapelle. The committee looks forward to having her work with us to make our valued trail system even better for all.

Given the current status of the pandemic, it might be possible for another volunteer workday this spring provided by local students. More information on that possibility in the April Messenger. Please continue to avail yourselves of all the recreation choices we have as a town.

News From the Broadband Committee

The committee is meeting twice in February to hear updates on progress with the bids and proposals received in the past few weeks. Updates were provided on grant and funding opportunities, vendor contacts, legislative actions and news from the WKLCBA.

The biggest news is that the WKLCBA has disbanded as the group determined they had met their mission. That was to work together to find a shared solution for broadband service to the member towns. After receiving the proposals, it became clear that the member towns would be proceeding in different directions. Some towns may still decide to work together as we each evaluate the proposals and negotiate with vendors.

The Readfield Broadband committee is now charged with deciding how to proceed to offer the town meeting two options: one being a Fiber-To-The-Home solution and the other an alternative solution. We are working with Fayette and Vienna to evaluate the proposals and to determine if there is a shared solution for the three towns. We will be meeting throughout the month of March to determine the best possible approaches for our town.

The Town Manager is working with Charter/Spectrum about our expired franchise agreement though the process is slow.

All meetings are public and will be held in person at the Town Office along with remote access. Look for links on the town website and for email alerts if you have signed up for them. Signup for email alerts is available on the town website. We publish monthly updates. <u>www.readfieldmaine.org</u>

Town Meeting Questions on Broadband

On November 2nd voters in Readfield spoke loud and clear by approving three articles concerning bringing Internet service to all locations in our town. There were 1015 residents who voted out of approximately 2300 registered voters. Of those who filled in a choice the results ranged from 70% to 78% approval. These votes have provided a clear direction to the Select Board and Broadband Committee. Both groups are committed to a prompt follow-through by assessing the available solutions and choosing the best and most equitable one to be presented at a Town Meeting in 2022.



Our groomers are ready to be back on the Readfield trails! Repairs have been made: a special thank you to Parks Performance who has supported the snowmobile club immensely again! But where's the snow? When preparing the February article for the Messenger, I was very happy for the snow to begin to arrive. This month I am saddened to see the snowless trails. APPLICATION FOR MAINE HOMESTEAD PROPERTY TAX EXEMPTION 36 M.R.S. §§ 681-689

Completed forms must be filed with your local assessor by April 1. Forms filed after April 1 of any year will apply to the subsequent year tax assessment.

INSTRUCTIONS

<u>SECTION 1.</u> Check the appropriate box related to each question. You must check all three boxes to qualify for the Maine homestead property tax exemption. If you have moved during the year and owned a homestead in Maine prior to your move, enter the address of the homestead you moved from on line 1b. Your ownership of a homestead must have been continuous for the 12-month period ending on April 1. If you did not check all boxes in this section, you do not qualify for the homestead property tax exemption. A person on active duty serving in the Armed Forces of the United States who is permanently stationed at a military or naval post, station or base in this state is deemed to be a permanent Maine resident. A person on active duty serving in the Armed Forces of the United States does not include a member of the National Guard or the Reserves.

SECTION 2. Enter your full name(s) as shown on your property tax bill, the physical location of your home, your telephone number, email address, and your mailing address, if different than the physical location.

<u>SECTION 3.</u> This section gives the local assessor information which may be used to determine if you qualify and should support your answers to the questions in SECTION 1. Please check the appropriate box for each of the applicable statements in this section.

At least one of the owners of the homestead must sign this document. Please file the application with your local municipal assessor. If, for any reason, you are denied exemption by the assessor, you may appeal the assessor's decision under the abatement statute, 36 M.R.S. § 841.

DEFINITIONS

Homestead. "Homestead" means residential real property owned by an individual or individuals and occupied by those individuals as their permanent residence. Residential real property held in a revocable living trust for a beneficiary who occupies the property as his or her permanent residence also qualifies as a homestead. A resident homeowner who is subject to foreclosure and subsequently purchases the home back from the municipality is considered to have no interruption in homeownership for purposes of this exemption.

Municipality. "Municipality" means any city, town, plantation, or that portion of a county in the unorganized territory.

Permanent residence. "Permanent residence" means that place where an individual has a true, fixed, and permanent home and principal establishment to which the individual, whenever absent, has the intention of returning. An individual may have only one permanent residence at a time and, once a permanent residence is established, that residence is presumed to continue until circumstances indicate otherwise.

Permanent resident. "Permanent resident" means an individual who has established a permanent residence.

A cooperative housing corporation may apply for a homestead exemption to be applied against the valuation of property of the corporation that is occupied by qualifying shareholders. To qualify, the corporation must complete an Application for Maine Homestead Property Tax Exemption for Cooperative Housing Corporations.

Please Note:

You only have to apply for the Homestead Exemption once (not annually). If you are unsure if you applied you can call the Town Office to check at 685-4939.If you are new to Readfield then please complete the form and return to the Assessor by April 1st.

Why are they a problem?

The browntail caterpillar has tiny (0.15 mm) hairs that on sensitive individuals cause a skin rash similar to poison ivy and/or trouble breathing.

- Avoid places heavily infested by caterpillars
- Take a cool shower and change clothes after activity that might involve contact with hairs
- Dry laundry inside during June and July to avoid hairs getting onto your clothing
- Use caution cleaning debris left by caterpillars because the toxin is extremely stable and remains a hazard for a number of years.
- In heavily infested areas, wear respirator, goggles, and coveralls (tightly sealed at neck, wrist, and ankles) when:
- * Mowing, raking, weed-whacking,
 - * Removing webbing, or
- * Performing any activities that stir up browntail caterpillar hairs
- Perform the above tasks on damp days or wet down material with a hose as moisture helps minimize contact
 - by keeping the hairs from becoming airborne. • Consult a physician if you develop a severe reaction

Browntail Control

Non-chemical:

- Clip overwintering webs and destroy by soaking in soapy water or burning. (Wear gloves!)
- Clip webs in the winter and very early spring: October to mid-April.
- If caterpillars are on structures hose down with water and vacuum up with a <u>HEPA filter vacuum</u>.

Chemical:

- Look for a licensed arborist/pesticide applicator; licensing ensures they have specialized training and equipment to do the job properly.
- If making a DIY pesticide application on your own property, select a pesticide product carefully:
- Ensure the intended site is listed on product label,
- Always FOLLOW LABEL INSTRUCTIONS,
- Preferably, choose a product that lists browntail moth on the label.
- Treat before the end of May to prevent development of the toxic hairs.
- Pesticide use within 250' of marine waters is restricted.

Identifying Winter Webs

Browntail overwinters as colonies of caterpillars in white silk tightly woven around a leaf or leaves in trees or shrubs. These webs contain 25 to 400 caterpillars, are spun in the early fall, and remain firmly attached to the tips of small branches all winter. The webs are often confused with silken structures formed by other less serious species of moths.

Browntail winter web description:

- 2-5 inches (5-10 cm) long
- white silk tightly woven around a leaf or small number of leaves
- string of white silk tying leaf petiole to twig
- small brown hairy caterpillars inside dense silk web




on branch tips of oak, apple, crabapple, cherry, shadbush and rugosa rose (occasionally other trees as well)

Often mistaken for browntail webs: Old fall webworm webs are formed by caterpillars in late summer, engulf the foliage and can become 2 to 3 feet (61-91 cm) long. By mid-fall the caterpillars have left the nests. During winter, the webs often hang loosely from branches.



- Hanging off of branches but NOT at branch tip
- Variable length, 3-24 inches (7-60 cm)
- Loosely tied mat of white or grey silk and debris
- Not associated with a leaf any leaves caught in the web not tied to twig
- Caterpillars not present in web in late fall/winter/spring
- On wide variety of deciduous hosts, especially ash and oak

Remnants of old tents of the eastern tent caterpillar can also be mistaken for browntail winter webs. These webs



are built in the **crotches** of branches on wild cherry and apple trees in late April and May and may be a foot or more long when fully formed. Eastern tent caterpillars are present in their webs from late April to June. Source: Maine Forest Service







THE WHITTIER HOMESTEAD

People have been asking us about the history of the house that burned on Tallwood Drive in February. First of all, we extend our sincere concerns to the homeowner, Lorraine Rourke. We are thankful that she and others living in the home were able to escape alright, and pray that Lorraine will soon recover from the trauma and be able to rebuild her home. House fires are a terrible and shocking kind of loss!

This house has been owned by only two families since c.1793. First settled by Samuel White, and then taken over by his son Henry, and Samuel's son-in-law Josiah Whittier. The property remained in the Whittier family until 1973 when Eugene & Grace Whittier sold it to Bill & Richard Rourke.

The original wooden house was torn down and rebuilt by Eugene Whittier in the 1940s, making the attached brick house (that burned) the older of the structures. The attached brick house was built c.1879 on 1/2 acre by father and son, George and Henry D. Whittier, making the property a duplex. George's youngest son Charles D. worked on his father's farm and lived nearby (where Bob & Joan Mohlar's house is now), while Henry and his wife Emma lived on the homestead. The next generation to live there were Henry & Emma's sons and wives, Don & Ethel and Eugene & Grace. Don died at age 39, four months after he and Ethel married and his widow moved to Florida. Eugene and Grace were the sole occupants until just before they both died in 1974. They did not have children of their own but the kids who grew up in the neighborhood and youngsters who came to the Lake in the summer were always welcome at the Whittier house.

The Whittier family was also significant regarding the development of the Lake Maranacook's eastern shore. They sold some of their water frontage to summer people and included a right of way through their pasture now called "Big Pines Lane". Henry Whittier was a carpenter and built some of the oldest cottages on the Lake, including the Sir Charles Hotel and cottages on Tallwood Peninsula in the 1890s. Many summer people considered the Whittiers good friends and we often hear mention of them from families who have been coming to Maranacook for generations. Their stories will live on no doubt because the Whittier family has been a big part of the local and summer resident's folklore on South Road and Tallwood Peninsula for a very long time.

Week 1: National Consumer Protection Week

It's National Consumer Protection Week —and while AARP is focused on protecting consumers year-round – this is a good time to highlight some key consumer protection tips.

Giving out personal or financial information to someone who contacts you is a high-risk proposition – be it by phone, email, text, or online. Rather than clicking links from texts and emails from your bank or from businesses you have accounts with, go to your app if you have one, or to a web browser and type the address in yourself - that way you know vou are going to the legitimate site. Lastly, engage your inner skeptic when a communication produces a strong emotional response; we know scammers want us "under the ether" of emotion to get us to believe their lies.

Week 2—Celebrity Imposter Scams

These days, celebrities share career news, personal views, even travel videos on social media and interact with fans in comment threads. But if you get a direct message out of the blue from a favorite musician, actor or athlete, don't get starry-eyed, get skeptical — it's almost certainly a scam. It's also always a scam when they ask for money for charity or say that you've won a large cash prize but need to pay an entry or processing fee.

Sadly, the AARP Fraud Watch Network Helpline hears about these scams all the time. Stars like Bruce Springsteen, Trace Adkins and Oprah Winfrey are among thousands of celebrities whose personas have been used by scammers online to solicit money from fans.

Remember, never share your personal information with or send money to someone you don't know and have only communicated with online, no matter how supposedly famous they are. Check that the social media account of your favorite celebrity is verified (look for the checkmark in a blue circle next to their name on Facebook and Twitter).

Week 3—Social Media Scans

The Federal Trade Commission (FTC) has declared social media a "Gold Mine" for scammers after consumers reported losing \$770 million in social media scams in 2021. That was double the amount of reported losses from 2020 – and we know fraud is severely under-reported, so the real losses are likely much higher.

The top three social media scams in 2021 were investment scams (many related to cryptocurrency), romance scams and shopping scams peddling counterfeit goods or not shipping anything at all.

According to the FTC, criminals are able to use the information we provide about ourselves on social media sites to target us with ads for fake products. The relatively low cost to advertise on these sites also makes it easier for crooks to cast a wider net.

To stay safe on social, make sure your privacy settings restrict who can see your personal information. Be wary of anyone you meet online who asks you to make an investment or help them out financially. Also, carefully research the company and product you might be interested in buying to make sure they are reputable.

Week 4—AARP ReST: Emotional Support for Fraud Victims

For many fraud victims, the financial toll is only part of the story; nearly two in three victims suffer a significant health or emotional impact, according to research by the FINRA Investor Education Foundation.

To address this reality, the AARP Fraud Watch Network and Volunteers of America (VOA) developed a free program to provide emotional support for people affected by fraud. AARP VOA ReST, which stands for Resilience, Strength and Time, features small groups whose participants are led in discussion by one or more trained peer facilitators. These online, hour-long sessions help to re-establish trust, integrate your experience and build back your resilience despite a difficult and painful occurrence. Discussions are confidential and you are welcome to attend one session or several - it's your choice.

Experiencing a scam can be devastating, but it doesn't have to define you. Visit www.aarp.org/fraudsupport to learn more about the free program and register today. Remember, you are not alone.

Week 5—Disaster Repair Scams

Extreme weather season seems to be a misnomer, with catastrophic weather events happening throughout the year these days. Whenever weather events occur, shady contractors and outright impostors flock to neighborhoods in search of "work" that they may or may not even attempt to do. Many will specifically target older homeowners who they perceive as more trusting, more likely to have savings, and – they think – may be experiencing cognitive decline.

It's safest to trust contractors that you proactively reach out to. Also, regardless of who you are talking to, get written estimates and compare bids from multiple contractors before starting any work. Finally, pay no more than a third of the total cost prior to the work beginning – and then only when materials arrive.

Committees remain active at the Readfield Union Meeting House as we head into March 2022.

The Fund Raising Committee has received an invitation from Maine Preservation to submit a grant request to the 1772 Foundation for additional maintenance work on north stained/stenciled glass windows. This grant



request has been submitted for the Feb. 25 deadline.

A \$10,000 grant request to fund the purchase of Vestry kitchen equipment and appliances has been submitted to the Maine Community Foundation's Community Building program. The Vestry Building Committee and the Friends of the Vestry/Meeting House collaborated with some community members on some of the details.

The RUMH Building Committee has received the Preservation Timber Framing (PTF) estimate for the restoration of the tower, belfry and attic. The estimate was higher than expected. The Building Committee will set up a meeting with PTF to go over details and make adjustments where needed. Updates on the restoration will continue in upcoming Messenger articles.

Volunteers Needed! Readfield Union Meeting House Co. depends on community help to complete its restoration.

An article is being written to the Community Advertiser, Lake Region Reader and Kennebec Journal with a list of jobs requesting volunteer help. We are a small Board of Directors carrying out many tasks and would love some help.

Free Workshops Available to Help Mainers Improve Health

Statewide - This March, Healthy Living for ME will be offer-

ing workshops focused on helping Mainers who are living with diabetes,

other conditions, as well as a workshop focused on helping people with Intellectual and/or Developmental Disabilities or Acquired Brain Injuries live a healthy lifestyle. Available across the state, with in-person, virtual, and telephonic options, these workshops are provided to the public through Healthy Living for ME's partnerships with local organizations and health systems.

"We're grateful for the partnerships that allow us to continue to bring workshops to Mainers. These workshops offer education and guidance for managing conditions and improving health while importantly providing a supportive space for participants," said Maija Dyke, Contract and Business Manager of Healthy Living for ME. "We invite any Mainer who is interested in joining these workshops to reach out to us for more information or to register."

Many of Healthy Living for ME's workshops are free to the participant, while others have a low cost. For virtual workshops, participants who do not have the necessary technology may be eligible to borrow an iPad from Healthy Living for ME in order to participate.

Healthy Living for ME's March workshops include:

• Living Well with Diabetes (in-person) - This workshop will be held in-person at the Alfond Center for Health in Augusta on Thursdays beginning March 3, 2022. It is designed to help people with type 2 diabetes by covering topics such as: dealing with diabetes symptoms, fatigue, pain, hyper/hypoglycemia, stress, depression, anger, fear, frustration, appropriate exercise, healthy eating, appropriate use of medication and working with healthcare providers. This workshop is provided in partnership with MaineGeneral's Peter Alfond Prevention and Healthy Living Center.

• **Better Health Now with Diabetes (by phone)** - Participants in this workshop will receive a free mail order toolkit and will work with a certified leader via phone or Zoom at a predetermined time. • The National Diabetes Prevention Program (virtual) - This workshop will be held virtually beginning on March 22, 2022. It is not a diet or exercise class, but a program led by a certified lifestyle coach that provides free health coaching to reduce a person's risk of developing Type 2 diabetes. Participants will learn to apply practical strategies to stay motivated, manage stress, prepare food, and avoid negative thoughts. Participants attend 16 weekly sessions followed by every other week sessions for the remainder of the year-long program. Additionally, our Registered Dietician will be available to support participants of the program.

• **HealthMatters (in-person)** - This workshop will be held in-person at the Muskie Community Center in Waterville on Mondays, Wednesdays, and Fridays beginning March 28, 2022. It is designed to help people with Intellectual and/or Developmental Disabilities or Acquired Brain Injuries and their supports live a healthy lifestyle. Through exercise, nutrition and health education activities, this workshop helps participants become stronger and healthier, improve self-advocacy skills and confidence, and connect with peers as they gain the knowledge, motivation and skills needed to create healthy habits that last a lifetime. This workshop is provided in partnership with Bridges Home Services.

• Living Well with Diabetes (virtual) - This workshop will be held online on Thursdays beginning March 31, 2022. It is designed to help people with type 2 diabetes by covering topics such as: dealing with diabetes symptoms, fatigue, pain, hyper/hypoglycemia, stress, depression, anger, fear, frustration, appropriate exercise, healthy eating, appropriate use of medication and working with healthcare providers. This workshop is provided in partnership with SeniorsPlus and the Lewiston/Auburn (L/A) Senior College.
