## **News from the Town Manager**

#### Town Manager's Report - Budget and Town Meeting Warrant Summary

I want to sincerely thank all of the residents, volunteers, and staff who have been working together to move our town forward through this year's budget and warrant process. The past two years of the COVID-19 pandemic have been incredibly trying for our community and the services provided by the Town. We've faced staffing shortages, project delays, inefficiency, and increasing costs. Despite these challenges we have been able to meet or exceed most expectations and have done so while lowering the tax burden for residents during the pandemic. Unfortunately we cannot responsibly continue that trend and we are anticipating an increase in the municipal tax impact in the upcoming budget year. Our approach to budgeting has not changed and neither has our primary goal - to provide the services residents want, at the level of service they expect as cost effectively as possible. The pandemic seems to have led to a shift in priorities for many residents and two of the biggest are the desire for more outdoor recreation opportunities and the need for reliable communication and technology. These priorities are reflected in the budget in the form of the Fairgrounds Community Park and Conservation Project and the Readfield Community Broadband Project. I'll talk more about those two projects specifically next month, but I encourage voters to pay particular attention to them. I believe the community benefits outweigh the costs but everyone needs to make their own informed decisions.

Here are a few summary budget and Town Meeting Warrant highlights:

- Most non-tax revenue streams are up, including a significant improvement in State Revenue Sharing projections. Bond proceeds are a major budgeted revenue to cover project specific costs.
- Expenses are expected to rise as a result of increased COVID related labor and material costs, and debt service payments for approved and anticipated borrowing.
- Assigned and unassigned municipal fund balances were used to minimize tax impacts.
- Changes are being proposed to the Board of Appeals and Land Use ordinances to make the language clearer and the administrative processes fairer and less complicated for everyone.
- The Warrant Article about continuing with Secret Ballot voting has been removed as that appears to be a settled issue for the foreseeable future.

Here are the key details on what else is on the ballot and where and when to vote:

Candidate's Night will be held on May 9<sup>th</sup> via ZOOM and in-person at the Town Office.

Select Board Candidates will participate from 6:30-8:00pm and School Board Candidates will participate from 8:00-8:30pm.

The final **Public Hearing** on the budget and warrant will be on **June 2<sup>nd</sup> at 6:30pm**. It will be held via ZOOM and in-person at the Town Office.

Remote / virtual participation for both of the above events will be essentially the same:



Baseball and Softball/Tball sign ups are going strong- we are hoping to make teams as April starts. The snow has melted early (I hope I don't jinx with a late spring storm) and now we wait for fields to dry. We are looking good with 1-2 teams at most levels. That is a total of 4-5 baseball teams and 3 softball teams as well as a couple T ball teams! This brings me to our proposal for field and basketball court development at Church Rd. I feel the more the idea of this project gets out to townspeople, there are different views depending on who and where you get your information. I would love to share some information from the Recreation Association who first revived the old design and keeps working hard to keep this project moving forward. All stakeholders have met and arrived at a design that includes suggestions from all. Recreation programs are in need of a decent softball field. The field we have been using for softball has been in desperate need of repairs for years- the investment in a field the town does not own(RES) is not a viable option. Our proposal puts a softball field to match outfields with the baseball field that exists on the Church Rd/Fairgrounds property. The fence in place in the baseball outfield now would be repurposed to the dugouts and infield fencing for the softball field. Multi-use fields would allow for soccer use in the fall as well as a possible additional practice field for youth football. The fields would also allow for outdoor concerts or other town activities during Heritage Days, Easter Egg hunt or Trunk or Treat.

Basketball is one sport anyone can play, young or old. I've heard folks of all ages excited about this part of our proposal. Imagine if our coaches could run a summer clinic and then keep play going all summer because they have open access to a court!! What if the kids you see riding bikes and fishing could play and develop their love of basketball as well? Not only will this development help everyone enjoy our trails and conservation lands more but it will help give options for the whole family. Building more of a field facility close to town, within walking distance to the beach, school and library is just priceless! I also understand the cost you may have heard or seen could discourage you to be in favor of this project. The amount on the proposal is an "up

to" amount. We are currently waiting on an updated cost analysis associated with the new landscape design. I want to assure you, we as a Recreation Association are fundraising and applying for grants to offset and minimize the final cost to taxpayers. I look forward to sharing more or answering any questions you have about the proposed Fairgrounds Community Park and Conservation Project.





## **NEWS & NOTES FROM THE TRAILS**

Hello trail enthusiasts.

Welcome to our spring walking/hiking season. It looks like our trails will be clear earlier than usual hopefully accompanied by some warmer weather. At this point we believe the trails are generally in good shape but there may still be wet spots. We are already discussing improvements for some of the Fairgrounds trails due to water and ice issues that occurred over the winter. We have created a subcommittee to work with the Conservation Commission to come up with a specific plan of work to be done this spring. The Community Pathway behind the library has also received recent attention from two of our members who removed invasive plants and cleaned up the path.



While on the subject of welcoming I would especially like to welcome our newest trails committee member Megan Larochelle. She actively participated in her first RTC meeting in March, and is already contributing as a member of the subcommittee looking at work needed on the Fairgrounds trails.

If you are willing to follow "Leave No Trace" principles (https://lnt.org/why/7-principles/) it is best for the trails to walk directly through the wet spots. Walking around the water causes both trail widening and erosion. As stated above trails committee members will be walking the trails to identify areas for repair and/or re-routing once things dry out. However, if you spot areas that need repair or re-routing please don't hesitate to call or email your suggestions (photos are especially helpful).

Please contact me if you are interested in volunteering for trail work or would consider joining the Readfield Trails Committee.

## **News from the Broadband Committee**

### **Current Status of Fiber Internet in Readfield** March 24, 2022

Select Board Issues Resolution of August 17th, 2020

The Readfield Select Board issued a resolution taking action on the broadband services available in our town. The goals are to:

- Establish a minimum service level of 100Mbps download speed and 10 Mbps upload speed, with up to 940 Mbps download speed and 35 Mbps upload speed available, if using a hybrid fiber/coax solution;
- Provide at least 100 Mbps download and upload speeds, and up to 1 Gbps download and upload speeds, if using a Fiber network solution;
- Establish 99% rate of reliability of service during any 24-hour period;
- Provide service to all (100%) properties in town; and
- Offer discounted services for low-income households with demonstrated need.

Voters Approve Spending Request November 2<sup>nd</sup>, 2021

#### Three articles were presented to the town meeting, summarized as follows:

- Authorize the Select Board to negotiate agreements through third-party service providers, with final agreements and funding requiring voter approval.
- Authorize the Select Board to enter agreements to accept and expend revenues received from any source to offset the costs of design, acquisition, construction and equipping a broadband fiber optic network.
- Authorize the Select Board to appropriate no more the \$5 million of general obligation bonds and notes, to provide for paying all or part of the costs of the foregoing broadband fiber optic network.

Readfield voters spoke loud and clear by approving the three articles concerning bringing Internet service to all locations in our town. There were 1015 residents who voted out of approximately 2300 registered voters. Of those who filled in a choice the **results ranged from 70% to 78% approval.** 

These votes have provided a clear direction to the Select Board and Broadband Committee. Both groups are committed to a prompt follow-through by assessing the available solutions and choosing the best and most equitable one to be presented at a Town Meeting in 2022.

Warrant Article Approval on June 14th, 2022 Warrant

The town has actively been pursuing solutions for the past two years. Our Town Manager, Select Board, and Broadband Committee have spent considerable time and effort to meet with each other, to work with an industry consultant, seek out solutions, discuss options, contact and meet with current and potential providers, contract for and receive needed pole data for our town infrastructure, issue a request for proposals for a solution, review the proposals received, negotiate a contract with a selected vendor, and keep the public informed through public meetings being broadcast, select board meeting updates, monthly newsletter updates, online surveys, mailings to all property owners and constructing an addition to the town website.

The Select Board authorized the Town Manager on March 14<sup>th</sup>, 2022 to enter negotiations with Axiom Technologies, LLC., of Machias, Maine to provide construction and service of a Fiber-To-The-Premises (FTTP) network for our town. We expect this to be finalized by April 1st, 2022, with all information being publicly posted after that time. This is for a town owned fiber network consisting of fiber cables strung throughout town and a central operations equipment building, along with all service needs being provided directly by Axiom Technologies.

As promised, the Select Board is seeking approval on the June 2022 Town Meeting Warrant to continue with this project. During the month of April, information will begin to be posted on the Town website under the Department titled 'Readfield Fiber', explaining all about what is proposed to be offered. There will be several public hearings/meetings held from March through June, articles in the Town Messenger, and direct mailings to all property owners. The Select Board is excited to offer this equitable, cost effective, reliable, high speed fiber network to our town making Readfield an even more desirable place to in which to live and work.

#### The Total Cost of Readfield Fiber

March 24, 2022

The Readfield Fiber network has been developed to be paid for in two ways: through a general obligation bond that will have the costs assessed to every property in town, and through subscriber fees. The vote on Article 4 at the November 2021 Town Meeting authorized the Select Board to borrow the funds to construct the network.

If the article to approve the contract with Axiom Technologies LLC is passed at the June 14<sup>th</sup>, 2022 Town Meeting, we will immediately proceed with the project. The funds will be borrowed in November through the Maine Municipal Bond Bank, and expended over a 12- to 18-month period as construction takes place. The full effect of the borrowing will not be in the budget being voted on in June as the first year payment is for interest only. We will most likely be taking a bond anticipation note in June if approval for the project is voted in so that construction can begin immediately, and we will have a relatively small interest payment for that in this fiscal year also. Both of those payments are already included in the budget voters are being asked to approve on June 14th. The full annual payments of principal and interest for the \$5 million bond will be in our annual fiscal year budgets for the following 19 years. (This is the same type of schedule we used for the building renovation projects at the Fire Department and the Library, and often for a new fire truck.) As with all capital projects, we will realize a multi-million dollar net increase in town assets after constructing the fiber network.

<u>Subscriber Fees</u>: Property owners in Readfield who choose to switch from their current internet service provider to the Readfield Fiber Network will pay just \$40 (proposed) each month to Axiom Technologies LLC if they choose the 100 Mbps symmetrical service. (This means you receive 100 Mbps download speed and 100 Mbps upload speed.) This is more speed than many households require to allow folks to do



multiple things at once on the internet, as well as to stream movies and play online games without waiting long times for downloads or experiencing constant buffering (pauses to what you are watching/doing.) There will be also be higher speed tiers of 250 Mbps, 500 Mbps & 1G available, each with a different monthly cost. These services will be available to **every** property address in our town that has a building, all at the same monthly cost for the same service. This meets the Select Board Resolution requirement that we provide service to all (100%) properties in town.

Assessment Fees: Property owners in Readfield will all contribute to the construction cost of the fiber network through their annual property tax bill in the same way as we all share the costs of roads, buildings, schooling, county assessments, protection costs for Fire and Ambulance service, and all other town expenses. The amount you will pay is based on the assessed value of your



property. The average assessed value for a home in Readfield is about \$250,000 and the tax impact of this fiber network will be approximately \$24 each month (proposed). If your property is worth less than that amount you will pay less. If your property is worth more than that amount you will pay more. This is how all services in town are apportioned every year for all expenses. In this way of paying for the construction costs, everyone who owns property shares in the value of the asset and in the cost acquiring it according to their level of investment in the town by owning property. Thus, folks who have less income often have less property and therefore will pay less, and folks who have greater incomes often have more property and will pay more. To look up your total assessed property value (both land & buildings), go to **readfieldmaine.org** Click on Tax Information on the left, then click on the Red print at the top of the page, then enter your last name in both Last Name boxes, click Search at the bottom, then click View next to your property on the new page.) *This meets the Select Board Resolution requirement that we offer discounted services for low-income households with demonstrated need.*

The Affordable Connectivity Program Provides Ongoing Assistance of a \$30 monthly credit for your service.

The Affordable Connectivity Program (ACP) is a Federal Communications Commission program that helps connect families and households who need assistance affording internet service. This new benefit provides an ongoing discount of up to \$30 per month toward broadband service for eligible households. Go to <a href="https://www.fcc.gov/acp">https://www.fcc.gov/acp</a> for the current details of the program including how to sign up for the credit. In summary, if the household income is at or below 200% of the Federal Poverty Guidelines, or if a member of the household meets at least one of these criteria

- Participates in certain assistance programs, such as SNAP, Medicaid, Federal Public Housing Assistance, SSI, WIC, or Lifeline;
- Participates in the National School Lunch Program or the School Breakfast Program, including through the USDA Community Eligibility Provision;
- Received a Federal Pell Grant during the current award year; or
- Meets the eligibility criteria for a participating provider's existing low-income internet program.

If folks qualify for this credit their monthly service cost would be as low as \$10 for 100 Mbps symmetrical service. (proposed) This meets the Select Board Resolution requirement that we offer discounted services for low-income households with demonstrated need.

### **Town Meeting Questions on Broadband**

On November 2<sup>nd</sup> voters in Readfield spoke loud and clear by approving three articles concerning bringing Internet service to all locations in our town. There were 1015 residents who voted out of approximately 2300 registered voters. Of those who filled in a choice the results ranged from 70% to 78% approval. These votes have provided a clear direction to the Select Board and Broadband Committee. Both groups are committed to a prompt follow-through by assessing the available solutions and choosing the best and most equitable one to be presented at a Town Meeting in 2022.

## **News From the Broadband Committee**

The committee met on March 2<sup>nd</sup>, 9<sup>th</sup> and 23<sup>rd</sup> for the primary purpose of evaluating the bids the town received for upgrading broadband internet service to every address in town. In depth discussions were had on all aspects of the bid proposals with the main criteria being that the service had to reach all properties and it had to provide at least 100 Mbps symmetrical. We were able to narrow it down to two bids at our first meeting, and then upon receiving more information about the two bid details, the committee unanimously choose Axiom as the preferred provider at our second meeting. A recommendation was made to the Select Board to pursue contract negotiations with Axiom. We then focused on updates from the Town Manager about the process moving forward and input received from Axiom at our third meeting.

The Select Board approved the recommendation on March 14<sup>th</sup> and agreed to place an article on the Town Warrant for the June 14<sup>th</sup> Annual Town Meeting. The article asks the town to approve Axiom as the preferred vendor and to enter a contract with them to build the fiber optic network throughout Readfield and then to operate the network on a long-term basis. This contract will provide 1-Gigabyte symmetrical fiber service to all locations, excellent customer service and network repair service, along with very affordable consumer pricing. Watch for more details to be posted as negotiations continue over the next month. We also plan to provide information to the public via an addition to the town website which will be live prior to absentee ballots becoming available on May 13<sup>th</sup>.

The committee is meeting next on April 13th. We will be discussing the results of the public budget meeting and hearing held on March 24<sup>th</sup> and any updates from Axiom and the contract negotiations. All meetings are public and will be held in person at the Town Office along with remote access. Look for links on the town website and for email alerts if you have signed up for them. ### tick removal

Remove ticks immediately. They usually need to attach for 24 hours to transmit Lyme disease. Consult a physician if you remove an engorged deer tick.

#### Using a tick spoon:

- · Place the wide part of the notch on the skin near the tick (hold skin taut if necessary)
- · Applying slight pressure downward on the skin, slide the remover forward so the small part of the notch is framing the tick
- · Continuous sliding motion of the remover detaches the tick

#### Using tweezers:

- Grasp the tick close to the skin with tweezers
- · Pull gently until the tick lets go

#### **Deer Ticks**

- Deer ticks may transmit the agents that cause Lyme disease, anaplasmosis, and babesiosis
- What bites: nymphs and adult females
- When: anytime temperatures are above freezing, greatest risk is spring through fall

#### **Dog Ticks**

- · Dog ticks do not transmit the agent that causes Lyme disease
- What bites: adult females
- · When: April-August

### prevent the bite

- · Wear light-colored protective clothing
- · Use EPA-approved insect repellent on skin or clothing
- · Use caution in tick infested areas
- · Perform daily tick checks
- · Protect your pets, use repellents, acaricides, and a Lyme disease vaccine for dogs

## lyme disease

Ticks usually need to attach for 24 hours to transmit Lyme disease.

Often, people see an expanding red rash (or bull's-eye rash) more than 2 inches across at the site of the tick bite, which may occur within a few days or a few weeks.

#### Other symptoms include:

- fatigue
- · muscle and joint pain
- · headache
- fever and chills
- · facial paralysis

Deer ticks may also transmit the agents that cause other diseases such as babesia and anaplasmosis.

People that remove an engorged deer tick should consult their physician as quickly as possible.



## "I LOVE TO TELL THE STORY", RHS PROGRAM SLATED FOR APRIL $30^{\mathrm{TH}}$

The Readfield Historical Society (RHS) will hold their annual meeting, the presentation of an annual award of appreciation to a community member, followed by a program on Saturday, April 30<sup>th</sup> 1-3 p.m. at Gile Hall, 8 Old Kents Hill Rd. The program offered is "I Love to Tell the Story," when six panelists ages 73-91, who are lifetime or longtime Readfield residents, will share stories and take questions from the audience about Readfield during the 20th century. Dale Potter-Clark, RHS board member will moderate the panel discussion.

Program panelists will include Evelyn (Adell) Potter, who was born in 1930 at Readfield Depot, grew up there and has lived at Kents Hill since 1946. Among other places, she has worked at Kents Hill School and in the Readfield Tax Assessor's office. Potter has also authored many articles and a book about her memories of Readfield and she is a founding member of RHS. Christopher Dumaine, Jr. will also be a panelist. His family moved to Readfield in 1938 so his father could help his newly widowed mother, Elizabeth Clarke, operate her 146 acre "Kennemac Farm". Mrs. Clarke had been a Boston socialite before her second husband, "Mac" decided to follow his dream of becoming a dairy farmer in 1927 and left his stock broker position in New York City to do so, in Readfield. Mac died suddenly on New Year's Day, 1938 and Chris related, "My grandmother, not knowing much about farming, called my dad in Manchester, NH and told him he had to get down here to run the farm because Mac was dead. My dad packed up my mother, my two month old brother and me and headed for Readfield but not before Mom was assured that Kennemac Farm had indoor plumbing and electricity." Additional panelists will include Melanie Lanctot, John Lord, Brenda (Boutilier) Deojay and Ed Dodge, who all have much to share about their experiences from years – or a lifetime – of living in Readfield.

All are welcome, there is no admittance fee but donations are welcome. Refreshments will be served. Attendees must be RHS members to vote during the business meeting.

Annual dues are \$5.00 for seniors or \$10.00 for others and can be paid or renewed at the door.




